The (**Application Fee\***) is required to initiate a **New Application**.

The (**Annual Registration Fee\*\***) is a yearly fee equal to the application fee paid by the applicant and is required to maintain registration, except for gaming facility operators where the annual fee will be assessed based on the previous fiscal year's gross annual gaming revenue. It must be submitted to the Independent Gambling Control Office (IGCO) each year on or before the registration anniversary date (THIS IS usually the date THAT registration was approved by IGCO) for the term of the registration.

#### **Costs of Background Investigations:** Section 180 and 181 *Gaming Control Act*.

Prior to the commencement of a background investigation, applicants for registration will be required to submit a deposit equal to the IGCO's written estimate of costs of the background investigation. The costs of a background investigation include but are not limited to the cost of the IGCO's staff time at \$150 per hour (per person), out-of-province travel costs, and where it is deemed necessary, the engagement of specialized financial management, or investigation advisory services.

#### **Payment Methods:** Wire transfers, money orders or company cheques are accepted.

Additional funds may be required to cover any special investigation, auditing, or administrative costs considered necessary by the IGCO to ensure a thorough and complete background investigation of the applicant or registrant.

You must accept any risk of adverse publicity, embarrassment, criticism or other action, or financial loss, which may result from action with respect to an application and expressly waive any claim for damages as a result thereof.

**After completing the forms**, ensure that all required documents are signed and that the application fee is included. (NOTE: The individual signing this document must submit a scanned colour copy of a valid government-issued ID that includes their full legal name, date of birth, signature and photograph - such as a driver's licence or passport - along with the application.)

**Retain a copy of your application and all submitted documents for your records.** Be prepared to bring your copy to any personal interviews that are conducted.

The Disclosure Form and supporting documents are to be submitted electronically, on a flash drive, or via a file-sharing service.
